38/25	Annual Report from Chair of Withiel Parish Council:- Annual Report received and circulated as follows for 2025:-	
	Withiel Parish Council has been extremely well supported by Cornwall Councillor Mrs. Jenny Cruse throughout the past year and also by the excellent Clerk – Mrs. Julie Burdon, who can always be contacted at clerk@withielparishcouncil.org.uk	
	Attendance by all Councillors has been good and some members of the public have attended meetings regularly, as ever it would be wonderful to have more attend and contribute.	
	Highways – During 2024 we finally saw the traffic regulation order come into effect limiting the access to the village of Withiel by traffic over 7.5 tons (except for access). Following some issues with the signs, facing the wrong way, all are now in place. Generally, there have been less issues with large lorries and damage although some still come through and some damage still occurs. If this is seen it is suggested that residents report breeches to the authorities so they can follow up.	
	The largest issue within the parish now appears to be the general poor state of the roads with potholes and floods appearing regularly. These are being reported and occasionally repaired but there are still concerns about the speed and quality of these repairs. Work is ongoing to try to improve this situation but we would still urge people to report issues they see directly to the County Council via their website. (https://www.cornwall.gov.uk/transport-and-streets/roads-highways-and-pavements/report-a-problem-with-a-road-highway-or-footway/)	
	Planning – 2024 feels like it has been a busy year with planning applications, with 12 decisions being made by Cornwall Council following our consultation and input. There have been a number of challenging cases, but the framework has been followed with Councillors referencing our own Neighbourhood Development Plan as well as the Local Plan, which all Councillors have personal copies of. This said our recommendations and comments can and are overturned or rejected by Cornwall Council who ultimately have the final say on these matters.	

Website - The website continues to operate and is now used more widely for people wishing to access Parish Council minutes and agendas and reports. This website can be viewed at https://www.withielparishcouncil.org.uk/

Finances - This part of the report was compiled by Councillor S. Coy, whose invaluable knowledge of the Parish Council finances is an asset to Withiel. Councillor S. Coy will be standing down this year and his long-term understanding of our budgets and accounts will be missed I am sure all will agree.

In the last financial year, Withiel Parish Council spent £12,872.11 against a real income of £14,398.50, an underspend of £1,526.39. However, the bank balance looks better than this due to the solar funds of £29,672.10 which are being held until expenditure on suitable projects to benefit the parish.

What do we spend your money on? We employ an excellent Clerk without whom we could not function, and her wages and expenses account for more than half of the £8,000.00 precept, the element of your Council tax we receive from Cornwall Council. We spent £564.00 on footpath maintenance during the year this in part is offset by a specific "footpath" grant of £398.75. The largest expenditure the Parish Council makes is towards Churchyard Maintenance this year it cost £620.00 to mow the two graveyards. The final major item is the maintenance of the Parish Council Website which, by law, we are required to maintain separately from the village website. There are a number of smaller items including a grant to our outstanding Parish Magazine "News and Views", a grant to operate the village defibrillator and some other minor items.

These can all be seen set out in the report of our Internal Auditor which will be available in the next two months, and which you can read on the website, or on the Parish Notice Board.

This will be the last meeting of the current cohort of Councillors with an election due to take place in May. I would like to take the time to thank all of you for attending our monthly meetings and inputting to discussion and debate. I hope that post the election the new Parish Council will work hard to ensure harmony and deliver the best for the parish we all love and call home. We look forward to welcoming more members of the public at future meetings and thank those who have attended regularly for their support.

Annual Report from Cornwall Councillor:- Report received from Cornwall Councillor Mrs. J. Cruse as follows:-

- It seems incredible that this is my fourth year as your Cornwall Councillor. The number of emails and cases has increased over this period of time, with more and more complex cases coming forward. The reduction in Councillors has increased our workload by 30% and is now a very time-consuming position. I have used the Casework Assist feature and found it generally effective to get to the right officer within the Council to deal with the matter.
- Committee work continues to take a great deal of time, since each meeting requires the reading of hundreds of pages, and all to be diligently read since

we are taking important decisions on many matters, particularly in planning and health care.

- I have taken this very seriously with a 92% attendance across all committees and Full Council. I have personally not been involved in finances or constitutional matters since I do not feel I have great expertise in that domain. Financially the Council has struggled partly to do with the payment of some rather nasty debts incurred by the previous administration which were due to impart a 53 million surcharge if not paid off and the increase in demand for Adult Social Care and Children's services as well as the increase in temporary housing requirements. The Portfolio holder for Finance and the Financial Officers have produced a balanced budget and they are to be congratulated particularly since the Labour Government has reduced funding and cut the Rural grant. I would add it was a piece of cross-party cooperation which enabled the Budget to be approved, and I feel this is particularly noteworthy.
- I enjoy my role on the Harbours Board and would like to mention how well this is run by the Maritime Manager Chris Jones, his grasp of all matters to do with the Harbours is excellent and our reserves have increased annually with some great improvements to some harbours. I have also found my role on the National Landscape Partnership very enjoyable and there have been some excellent public participation events where we have been able to involve residents who may not normally access these wonderful spaces.
- I have also been pleased to note that more members of the public have used the 'report it' system which has enabled a more accurate recording of where problems are positioned, and I have always found it to be a very effective system.
- There is much to be said for continuity, and it is my hope that our administration is able to continue looking after Cornwall in the following four years.

- I am, however, willing to give assurances that the Hall's finances are in a healthy state, with bank balances well in excess of our planned reserves.
- Hall Hires, fund-raising and donations are all good.
- Our large one-off expenditure items in the year were patch repairs to the car park and a refurbishment of the kitchen.
